Subject: Proceedings under section 17(2) - Order

In exercise of the powers vesting with the undersigned under sub-clause (b) of Clause (ii) of the 1st proviso to Section 17(2) of the Income Tax Act, 1961 read with Rule 3A(1) of the Income Tax Rules, 1962, approval is hereby granted to **M/s Vaga Hospital Pvt. Ltd., KS-14, Aliganj Housing Scheme, Sitapur Road, Lucknow-226020 (PAN-AAGCV2426E).**

2. The approval accorded as above is only for the purpose of sub-clause (b) of Clause (ii) of the 1st proviso to Section 17(2) of the Income Tax Act, 1961 and should not be construed as approval of the Central Government or the Pr. Chief Commissioner of Income Tax, Lucknow or any other statutory authority under the Government, for any other purpose(s).

3. This approval is subject to withdrawal at any time, if it is found that the approval has been obtained through fraud and/ or misrepresentation of facts, or necessary conditions as stipulated in sub-rule (1) of Rule 3A of the Income Tax Rules, 1962 are not fulfilled and is subject to modification/withdrawal, if necessitated by subsequent changes in the provisions governing the approval.

4. The approval is granted for the treatment of the following diseases and ailments:-

- (a) Cancer.
- (b) Tuberculosis.

- (c) Diseases or Ailment of the heart, blood, lymph glands, bone marrow, respiratory system, central nervous system, urinary system, liver, gall bladder, digestive system, endocrine glands or the skin, requiring surgical operation (Surgical facilities for major heart and liver surgery not available as no CTVS surgeon and there is no cath lab).
- (d) Ailment or disease of the eye, ear, nose or throat, requiring surgical operation.
- (e) Fracture in any part of the skeletal system or dislocation of vertebrae requiring surgical operation or orthopedic treatment.
- (f) Gynecological or obstetric ailment or disease requiring surgical operation, caesarean operation or laparoscopic intervention.
- (g) Ailment or disease of organs mentioned at (c) requiring medical treatment in a hospital for at least three continuous days.
- (h) Gynecological or Obstetric ailment or disease requiring medical treatment in a hospital for at least three continuous days.
- (i) Burn injuries requiring medical treatment in a hospital for at least three continuous days.
- (j) Anaphylactic shocks including insulin shocks, drug reaction and other allergic manifestations requiring medical treatment in a hospital for at least three continuous days.

This approval is granted w.e.f. 22.09.2022 and shall remain in force for three years from 22.09.2022.

This order of the approval is subject to the following terms and conditions:-

- (a) This approval is not transferable.
- (b) The Hospital shall at all reasonable times be open for inspection by the authority of Income Tax Department, duly authorized in this behalf.
- (c) The hospital shall conform to such conditions as are prescribed under sub clause (b) of clause (ii) of 1st proviso to section 17(2) of the Income Tax Act, 1961, read with Rule 3A of the Income Tax Rules 1962. In the event that the hospital ceases to satisfy any of the conditions prescribed by law, it will be mandatory on the part of the hospital to inform the authority granting the approval of such fact immediately.

- (d) The application for renewal of approval should be **submitted at least 90 days** before the expiry of the current approval.
